### Minutes - Annual Congregational Meeting - May 25, 2016

The meeting was called to order by President Nick Levitin at 7:35 pm.

Rabbi Greenstein gave a D'var Torah in which he discussed the pilgrimage festivals and what is expected of us in terms of our commitment to Gd and in terms of our commitment to ourselves and to each other. The Rabbi then thanked Nick for his extraordinary efforts on behalf of Shomrei for the past two years as President, and before his presidential term began as well.

Carol Katzman moved that the minutes form the Annual Meeting of 2015 be accepted. This motion passed unanimously.

Nick presented the President's report, speaking about the Sustaining Share Financial commitment model being a success in the steady level of income it has generated, Nick reminded anyone who hasn't pledged for the new year to please do so. He also spoke about the bottoms-up Budget which will be presented, and about successful programs such as Hinei Mah Tov, which has been a magnet for families.

Nick emphasized that we need more members and he spoke of the hope that Preschool will be a bridge to families enrolling their children in JLC as a step to their becoming members of Shomrei.

Heather Brown, incoming Education Director, spoke of the new curriculum and introduced her assistants, Aylah Winter and Lily Lucey.

Shirley Grill spoke about the new initiative, @nourish, which will provide engaging speakers who will help to engage and build the community on Shabbat.

Andy Silver spoke about the Sustaining Share Dues model and its successful first year.

Nick presented the Slate of new Officers and new Trustees. A motion was made to elect them. It passed unanimously. Nick thanked the Board, the Officers, Marge Wise, Sara Birnbaum, Heather Birnbaum, Rabbi Greenstein and his wife, Audrey. Certificates of appreciation were presented to Sarita Eisenberg, Rich Epstein and Alex Kent who are going off the Board.

The budget was presented by Bela Schwartz and Pam Golden. It was discussed and passed.

Nick congratulated Fern Heinig and all the Officers and Board members who will lead Shomrei in the months and years ahead.

Fern then thanked Nick for his leadership and devotion to Shomrei.

Carol Katzman made a motion to adjourn the meeting. It passed unanimously. The meeting was adjourned at 8:30 pm.

## President's Report May 2017

Shomrei has made advances in 2016-17 toward my vision of stronger community and financial stability.

#### Finance – Béla Schwartz and Pam Goldin

We are tracking overall on budget with a profit of \$4K.

SSFC commitments came in \$10K over budget net of reserves. However, there is still \$52K to collect. If we collect 75% of that cash will be equal to budget.

Programming revenue came in \$8.4K below budget primarily due to lower Kiddush revenues (both sponsored Kiddushes and contributions). Kiddush expenses are projected to be about \$3.3K lower than budget.

Major expense variances to budget were:

- Credit card expenses were \$27.8K, \$10K over budget
- Custodial costs were close to budget but only because we have two employees at much lower rates and only one employee for a period of about 4 months.

ILC and Preschool net income came in combined \$4.2K over budget.

- Summer Camp generated a profit of \$24.4K, which was \$7.5K over budget
- Preschool generate a profit of \$84.2K which was \$4.6K over budget
- ILC was a loss of \$74.4K, basically on budget.

#### **Education** – Heather Brown

The Preschool enrolled 55 students this year, and we enjoyed a successful year of growth in many respects. This was our largest enrollment in the past 5 years. Our before and aftercare offerings continue to help us meet and exceed budget, with parents paying "a la carte" pricing for last minute additions and extra hours paid at a premium price. Families also have the option to enroll in aftercare "plans," which also generate a generous percent of our aftercare income. We will continue this model in the coming year, since it is very popular and convenient for families and has afforded us much positive word of mouth in the general community.

The Preschool Art Auction remains our largest fundraiser of the year. This year's auction netted \$6k and was our most successful event yet.

The JLC proudly launched a new administrative team this year, in addition to an entirely new curriculum model that is student-centered, progressive, and places child-directed learning at the forefront. New furniture set the tone for individual and small group work, allowing students to work more comfortably on the floor or in centers, rather than sitting behind formal desks. Our teachers also trained in a new teaching style, where they serve more as inspirational mentors, who assist

student learning. The teachers no longer deliver material in a frontal teaching style, but rather now present materials in eye-catching and enticing ways on our shelves for students to select. The teachers move from each grouping of students, assisting them and encouraging them to try new materials.

We had 43 students enrolled in JLC this year, which includes 6 STOM students. We operated 2 multi-age classrooms, which will be expanded to 3 different classrooms (K-1, 2-4, and 5-7) for the fall. In addition, we are training and empowering new staff members to bring our vision to life in a stronger way for the coming year.

Our Family Chanukah Celebration, Purim Carnival, and Passover Family workshop all highlighted the warm community and interactive learning styles of both the preschool and JLC this year. Our Hinei Mah Tov Family Service, which became an integral part of the JLC curriculum, also became a showcase of the learning students accomplished in class, while at the same time allowed families to pray, debate, and question together in a spiritual and safe setting.

# **Membership** – Allison Task

Thank you for supporting our Membership initiatives at Shomrei this year. It was an honor to take the VP, Membership position just years into our Sustaining Share Membership Model. In addition to welcoming our new member families, the membership team placed it's energy and effort into building sustainable systems to help membership move forward. Not the most visible work, but necessary for our efficiency and structure moving forward.

As many of you know, Shomrei is able to offer a competitively price preschool program since the preschool is housed within our building. Our goal is to welcome these families (at last count, 54 children) into Shomrei at such an important time in their young children's lives.

Since approximately 50% of the preschool is comprised of interfaith families, next year we will be engaging in a listening tour, finding out what kind of a religious program the families are interested in having. The parents have started their children with a strong religious foundation: what would they like to see next?

# **Programming** – Liza Cohn

The Programming Committee oversaw several events over the course of the year, including Taste of Shabbat, the Annual Dinner Dance, a Second Seder for Passover, monthly Yoga and a Dad's night. There were many successful Tastes of Shabbat

hosted by congregants throughout the year, most held at congregant's homes, but at least once it was so well subscribed that it was it was moved to the synagogue. Thanks to all our generous hosts. Shomrei also hosted a "Shabbat Across Shomrei"- thanks Deb Caplan for organizing and those families who opened their homes for the evening!

The Annual Dinner Dance - this year themed "Mensches & Martinis" - honored Rich Epstein and Susan Lazev and was chaired by June Zimmerman, with the help of many congregants, including Rachel Kanter and Gail Stocks. It was an extremely festive evening with several special features, including a fabulous martini bar, live jazz music with an ensemble led by Jeremy and Maya Stepansky, as well as congregant, Sebastian Posada, and guest speaker Jules Epstein. The Social Hall looked stunning with decor donated by Louisa Testa. Over 130 people enjoyed this celebratory evening. And a special shout out to John Lasiter for his incredible graphics.

# @Nourish - Shirley Grill and Adrienne Schulman Lasiter

- 13 sessions scheduled; 12 held (one cancellation)
- Average attendance around 35: high of 80, low of 6; total participation about 420 people
- There are 10 school families who have attended regularly; remainder of attendees are from the congregation and other Preschool and JLC parents.

# **Shomrei Refugee Assistance Group** – Nick Levitin and Andy Silver

Twenty people showed up at the first meeting on Sunday, March 5<sup>th</sup>. The purpose was to explore what Shomrei as a community could do to help refugees and immigrants in our area.

A number of synagogues and churches are attempting to respond to this situation by actively working on behalf of refugees and other immigrants who are in need of support. We reviewed what synagogues and other groups in our area are doing, what we can do, and what we would be willing to commit to doing as members of our community. Within a week after the first meeting more than 50 people signed up to who wished to participate in this work. Progress has been slow as we find our way. But we have connected with other groups and begun to take action.

- 1. A few members of our group have begun to develop relationships with two recently resettled Syrian refugee families. Both families are doing well in the United States, but need a few items to help ease their transitions to their new homes. We are collecting these items and making periodic deliveries to the families.
- 2. Rabbi Greenstein along with several members of our group attended a "Faith in NJ event" at the Bethany Baptist Church in Newark. Entitled "No One Stands or Fights Alone" this gathering of 500 clergy leaders and members of many faith traditions focused on advancing immigration reform, and advocating for justice and humane treatment of refugees.
- 3. Meredith Lopez and Merrill Silver accompanied one of the recent refugees resettled by One World, One Love to the library in Elizabeth to help her get a library card and explore the resources of the library.
- 4. A small group of Shomrei members and the Rabbi attended a Syria Supper Club dinner in Glen Ridge where Andy and I made contact with Linda Woodbury of the Greater Bloomfield Interfaith Partnership (GBIP) Refugee Resettlement Group. This group is an alliance of faith communities working for justice, compassion and peace with Temple Ner Tamid, Glen Ridge Congregational Church, and several other churches in the area. They also work hand-in-hand with Church World Service one of seven government approved Refugee Resettlement agencies in the U.S. Linda invited us to a

steering committee of her group the following evening. Andy and I could not make it and asked members of our group if anyone could attend.

### **Buildings and Grounds - Marc Chalom**

Much needed repairs have happened. New carpeting had been laid in the social hall and the dance floor has been fixed and a new shine given. We have had tremendous flooding issues on the first floor near the library and hallway. The window casings have been repaired/replaced to hopefully solve the problem. The flat roof has been leaking; a roofer is repairing that also. There have also been upgrades to our security system as we reevaluate our security needs.



# Congregation Shomrei Emunah Budget Summary for Fiscal Year Ending 2018

On behalf of the Finance Committee (Pam Goldin and Béla Schwartz), we are pleased to present to the congregation the attached budget for the fiscal year ending in 2087. This budget shows a surplus of \$1.5K.

The budget this year, as last year, was developed "bottoms up" by working with the actual expenses for the prior year and analyzing the spending patterns. The JLC and Pre-School budgets were prepared by Heather.

Some general comments about the budget are below.

### Sustaining Share Revenue

- 153 households (259 individuals) have responded out of a total of 210 member households (72%) as of May 18. This compares with a 65% response rate as of the same date last year. The group has pledged 0.5% more in the aggregate than for the current year (basically flat). Current year commitments as of the same date last year were w1.2% lower than the prior year.
- \$21,123 of the generous match has been earned from the above contributions. For the current year the match was \$19,800.
- The remaining households have been budgeted at 90% of their current year contribution, provisionals have been dropped and a \$3K additional reserve has been included.
- With two months to go in the fiscal year, the actual unpaid amount from current year SSFC is \$19.5K or about 3.6% of total pledges. Some of this is from people on a payment plan. A 2.1% reserve (excluding match) on pledges was included in addition to the \$3K reserve.

### **Jewish Learning Center**

- Pre school
  - We have budgeted 53 students for preschool. As of May 18th, 32 students have registered for next year's preschool. Currently there are 55 enrolled.
  - Pre School is budgeted to generate a profit of \$90.3K vs. current year projected profit of \$84.2K. This is primarily due to a decrease in teacher compensation.
  - Summer Camp is budgeted to generate a profit of \$19K vs current year projections of \$24.4K. This is primarily due to the addition of \$4K in costs for security during Summer Camp.
- ILC
  - We are budgeting a loss of \$77K this year vs. a projected loss of \$74.3K this year. Both revenues and expenses are budgeted to be higher than current year with expenses \$2.6K higher than revenues.
  - We began awarding scholarships to JLC in the current year and continue to do so on an as needed basis this year. \$6.5K.of scholarships have been budgeted.
- JLC/Preschool/Summer Camp combined is budgeted to generate a surplus of \$13.2K vs. a current year projection of \$9.8K.

#### A note about current year projections:
